MODE OF MEETING

In view of the COVID-19 outbreak and as part of the safety measures, the Postponed Extraordinary General Meeting ("EGM") will be conducted entirely through live streaming from the Broadcast Venue. This is in line with the Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 18 April 2020, including any amendment that may be made from time to time.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act, 2016 which requires the Chairman of the meeting to be present at the main venue of the meeting. Shareholders **WILL NOT BE ALLOWED** to attend the Postponed EGM in person at the Broadcast Venue on the day of the meeting.

REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Shareholders of the Company are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the Postponed EGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at <u>https://tiih.online</u>.

Shareholders who appoint proxies to participate via RPV in the Postponed EGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **Monday**, **8 June 2020 at 11.00 a.m.**

Corporate representatives of corporate members must deposit their original certificate of appointment of corporate representative to Tricor not later than **Monday**, 8 June 2020 at 11.00 a.m. to participate via RPV in the Postponed EGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor not later than **Monday**, **8 June 2020 at 11.00 a.m.** to participate via RPV in the EGM.

A shareholder who has appointed a proxy or attorney or authorised representative to attend, participate, speak and vote at this EGM via RPV must request his/her proxy or attorney or authorised representative to register himself/herself for RPV at TIIH Online website at <u>https://tiih.online.</u>

As the Postponed EGM is a fully virtual EGM, members who are unable to participate in this EGM may appoint **the Chairman** of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

PROCEDURES FOR RPV

Shareholders/ proxies/ corporate representatives/ attorneys who wish to participate in the Postponed EGM remotely using the RPV are to follow the requirements and procedures as summarized below:

(a)	Register as a user with TIIH Online	 Using your computer, access the website at <u>https://tiih.online</u>. Register as a user under the "e-Services". Refer to the tutorial guide posted on the homepage for assistance. If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online. 		
(b)	Submit your request	 Registration is open from 9.00 a.m. Friday, 22 May 2020 up to 11.00 a.m. Monday, 8 June 2020. Login with your user ID and password and select the corporate event: "(REGISTRATION) PGB Postponed EGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting". Review your registration and proceed to register. System will send an e-mail to notify that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors as at 3 June 2020, the system will send you an e-mail to approve or reject your registration for remote participation.

(c)	Login to TIIH Online	 Login with your user ID and password for remote participation at the Postponed EGM at any time from 10.40 a.m. i.e. 20 minutes before the commencement of the EGM on Wednesday, 10 June 2020 at 11.00 a.m. 		
(d)	Participate through Live Streaming	 Select the corporate event: "(LIVE STREAM MEETING) Postponed PGB EGM" to engage in the proceedings of the Postponed EGM remotely. 		

		 If you have any question for the Chairman/ Board, you may use the query box to transmit your question. The Chairman/ Board will endeavor to respond to questions submitted by remote participants during the Postponed EGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.
(e)	Online Remote Voting	 Voting session commences from 11.00 a.m. on Wednesday, 10 June 2020 until a time when the Chairman announces the completion of the voting session of the Postponed EGM. Select the corporate event: "(REMOTE VOTING) POSTPONED PGB EGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
(f)	End of remote participation	• Upon the announcement by the Chairman on the closure of the Postponed EGM, the live streaming will end.

Note to users of the RPV:

- 1. Should your application to join the meeting be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

PROXY

The Postponed EGM will be conducted via virtual meeting, if you are unable to attend the meeting via RPV on 10 June 2020, you may appoint the Chairman of the meeting as proxy and indicate the voting instructions in the Proxy Form.

You may submit your proxy form to Tricor at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or its Customer Service Counter at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, not less than forty-eight (48) hours before the time appointed for holding the EGM or any adjournment thereof, otherwise the proxy form shall not be treated as valid.

You may also submit the proxy form electronically via TIIH Online website at <u>https://tiih.online</u> no later than Monday, 8 June 2020 at 11.00 a.m. Please do read and follow the procedures below to submit proxy form electronically.

ELECTRONIC LODGMENT OF PROXY FORM

b	Proceed with submission of Proxy Form	 After the release of the Notice of Meeting by the Company, login with your user name (i.e. email address) and password. Select the corporate event: "Submission of Proxy Form". Read and agree to the Terms & Conditions and confirm the Declaration Insert your CDS account number and indicate the number of shares for your proxy(s) to vote on your behalf. Appoint your proxy(s) and insert the required details of your proxy(s) or appoint Chairman as your proxy. Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide your vote. Review and confirm your proxy(s) appointment. Print proxy form for your record.

POLL VOTING

The voting at the Postponed EGM will be conducted by poll in accordance with Paragraph 8.29A of Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting).

Shareholders/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from the commencement of the Postponed EGM at 11.00 a.m. on 10 June 2020 but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to item (e) of the above Procedures for RPV for guidance on how to vote remotely from TIIH Online website at <u>https://tiih.online</u>.

Upon completion of the voting session for the Postponed EGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

PRE-MEETING SUBMISSION OF QUESTION TO THE BOARD OF DIRECTORS

Shareholders may submit questions for the Board in advance of the Postponed EGM via Tricor's TIIH Online website at <u>https://tiih.online</u> by selecting "e-Services" to login, pose questions and submit electronically no later than **Monday, 8 June 2020 at 11.00 a.m.**. The Board will endeavor to answer the questions received at the EGM.

NO DOOR GIFT/FOOD VOUCHER

There will be **no distribution** of door gifts or food vouchers for the Postponed EGM since the meeting is being conducted on a fully virtual basis.
